-Surety Reduction Review- Requirements

Requests for **Surety Reduction Reviews** for eligible sureties may be made at any time during the life of the project. **Requests for a one-time reduction (excluding BMPs) must be in writing using this form** and must be accompanied by a copy of the recorded plat and any subsequent revisions (highlighted for improvements where appropriate).

Surety Reduction Reviews may require up to thirty (30) days to complete unless otherwise informed.

Upon receipt of an approved **Surety Reduction Review**, the issuing Bank, Surety Company or Surety Agent will then require time to process the Amendment or Rider necessary to officially amend the Surety on file with the Engineering Department. We therefore encourage our customers to send Reduction Review Requests well in advance of due dates for Letters of Credit and Continuation Certificates (Surety Bonds), as reduction reviews *in progress* do not affect due dates for these documents. The Town's **surety reduction fee is \$200.00**. Please make payable to the Town of Indian Trail send to the attention of the Engineering Department.

For **Surety Release**, please utilize the Surety Release Packet. Please complete the required information and return to the Town of Indian Trail Engineering Department. The Town's **surety release fee is \$150.00** should be made payable to the Town of Indian Trail.

All fees should be delivered in the form of certified check or money orders only.
